## LETTER SUPPORT FOR CENTRAL WA. UNIVERSITY COMMISSIONERS

He explained that he had received a request from Central Washington University (CWU) asking for a letter of support from the County on the LHHS appropriations bill, regarding a program currently included in the FY 2011. Commissioner Crankovich moved to approve Board signature on a letter of support for CWU addressed to Senator Murray, Senator Cantwell and Representative Hastings. Commissioner Jewell seconded. Motion carried 3-0.
