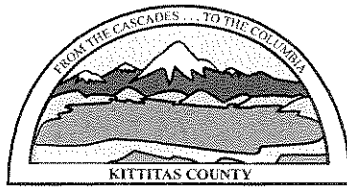

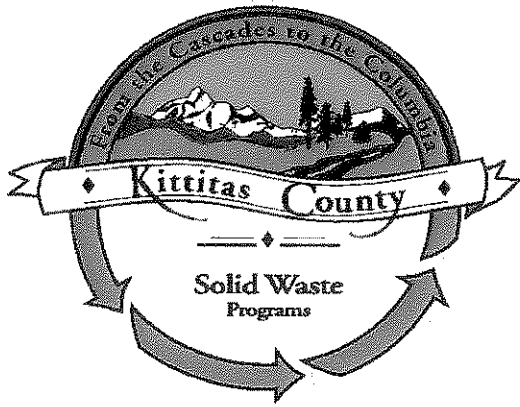

I have reviewed the event application regarding the Whisky Dick Triathlon which is scheduled for July 28<sup>th</sup> 2013 from 6:00-2:00 p.m. BuDu Racing has held this event for many years in which we have volunteered with assisting them in traffic control. But, according to their application this year they have changed the route and are asking us to close Vantage highway in its entirety from #81 Road to the Vantage boat ramp. Due to the extremely high average daily traffic (ADT), the amount of signage needed is not feasible for Public Works to approve of a closure of this magnitude. If Vantage highway is closed, but still open to local traffic only I would approve this request. Also I don't see any problems with closing the boat ramp and parking area for the short duration in the a.m.
