BACKGROUND:

The City of Kittitas has applied for a Commercial Public Utility Franchise to comply with Kittitas County Code requirements in regard to an existing water supply line that crosses the Right of Way on Clerf Road and Caribou Road. This water line provides water from a water source on Robert Clerf's property to the water tower located at the intersection of No. 81 Road and Clerf Road, in the City of Kittitas.

The City of Kittitas is taking over the maintenance and repair of the waterline that crosses the Right of Way on Clerf Road and Caribou Road. This necessitates a Franchise agreement with Kittitas County Public Works. The application is complete and in order and the appropriate Application Fee has been collected.
