**TO AWARD THE BID TO FURNISH TWO (2) NEW MOTOR GRADERS**

**WHEREAS:** A Notice of Call for Bids was advertised to furnish Two (2) new Motor Graders and dispose of E.R.R. #278 – 1991 John Deere 770D Grader, E.R.R. #279 2005 John Deere 770D Grader; and

**WHEREAS:** Sealed bids were opened on August 25, 2010, in the Kittitas County Public Works Office. Two (2) bids were received; and

**WHEREAS:** Pape` Machinery submitted a bid to sell two new graders in the amount of \$224,500 per Grader (excluding sales tax) and purposed a 5-Year Guaranteed buy back in the amount of \$137,000 per Grader; and

**WHEREAS:** The Public Works Department recommends that the responsible bid from Pape` Machinery for the two 6X6 Graders in the amount of \$224,500 per grader (excluding sales tax) with the 5-Year guaranteed buy-back option, be accepted as the lowest bidder to meet specifications ;and

**WHEREAS:** The Board of County Commissioners signed Resolution 2010-092 that declared E.R.R. #278 – 1991 John Deere 770D Grader, E.R.R. #279 2005 John Deere 770D Grader surplus to the County's needs; and

**WHEREAS:** The disposal of E.R.R. #279 2005 John Deere 770D will occur through a "Buy Back" guarantee through Pape` Machinery in the amount of \$ 110,000; and

**WHEREAS:** The disposal of E.R.R. #278 – 1991 John Deere 772BH will occur through a trade-in transaction with Pape` Machinery.

**NOW, THEREFORE BE IT RESOLVED** that the Board of County Commissioners, in the best interest of the public, does hereby award the bid to purchase two (2) Motor Graders to Pape` Machinery in the amount of \$224,500 a piece (excluding sales tax), with said award conditioned upon the terms and conditions as specified in the Proposal submitted by said bidder.

**BE IT FURTHER RESOLVED** that the Public Works Director be authorized to sign the contract documents for the bid awarded hereunder pursuant to the terms and conditions as specified in the Proposal submitted by said bidder
