Department of Corrections Contract No. K9561 Amendment No. 1

This Annendment is made by the state of Washington, Department of Corrections, hereinafter referred to as Department, and Kittitas County, hereinafter referred to as the County, for the purpose of amending the above-referenced Contract, heretofore entered into between the Department and the County.

WHEREAS the purpose of this contract amendment is to extend the period of performance, amend the base rate, and add language;

NOW THEREFORE, in consideration of the terms and conditions contained herein, or attached and incorporated and made a part hereof, the Department and County agree as follows:

The following sections are amended, in part, as follows:

**Section 2.1** <u>Term.</u> This Agreement supersedes all previous oral and written contracts and agreements between the parties relating to the confinement, care, and treatment of Department Offenders. This Agreement commences on August 1, 2012, and continues through ((December 31, 2013)) December 31, 2015, unless terminated by either party pursuant to this Agreement.

**Section 3.1** <u>**Target Population.**</u> Department Offenders transferred to the County will be primarily, but not exclusively, those who are in violation of community supervision requirements, awaiting a hearing on alleged violations, <u>parenting sentencing alternative violators</u> and work release violators.

**Section 3.11** <u>Billing.</u> The base rate will be sixty (\$60.00) dollars per day per Department Offender ((for the first calendar year of this agreement)). <u>Upon execution of</u> this Amendment 1, the daily rate shall be sixty one dollars and eighty cents (\$61.80) for the term of this amendment. The rate for subsequent years shall be negotiated by the parties annually and shall in no case exceed what is statutorily allowed. The County agrees to bill monthly for the actual bed days used in the preceding month. The County also agrees to submit itemized bills to the Department in electronic spreadsheet format that includes the Offender name, DOC number, Date of Birth, and dates the Offender was held under the Department's authority.

## The following is added to Section 5.2:

Should the contractor fail to comply with PREA standards, the Department is authorized, following notice and a reasonable opportunity to cure, to terminate this agreement.

Additions to this text are shown by <u>underline</u> and deletions by ((strikeout)). All other terms and conditions remain in full force and effect. The effective date of this amendment is upon final execution by the parties.
