DESCRIPTION/JUSTIFICATION OF AMENDMENT, MODIFICATION, OR CHANGE ORDER: The contract provides financial assistance to the County solely for the expenses necessary to answer 911 calls originating in the county, which includes performing certain tasks and maintaining certain equipment necessary to operate Wireline and Wireless Enhanced 911. Reimbursement shall be solely for eligible items included in Chapter 118-66 WAC. This amendment is necessary to adjust the funding in the Budget sheet (Exhibit C) based on updated expenditures and projected revenues and to change the contract expiration date to meet biennium closure requirements.			
11. AMENDMENT TERMS AND CONDITIONS: <ol style="list-style-type: none"> 1. Change the contract expiration date from September 15, 2013 to August 15, 2013. 2. Contract performance period of July 1, 2011 through June 30, 2013 remains unchanged. 3. Change the overall contract amount from \$597,006 to \$555,608; a decrease of \$41,398. 4. The overall FY12 funding amount of \$264,286 remains unchanged. 5. The overall FY12 Wireline funding amount of \$117,556 remains unchanged. 6. The overall FY12 Wireless funding amount of \$146,730 remains unchanged. 7. Change the overall FY13 funding amount from \$332,720 to \$291,322; a decrease of \$41,398. 8. Change FY13 Wireline funding amount from \$134,108 to \$131,439; a decrease of \$2,669. 9. Change FY13 Wireless funding amount from \$198,612 to \$159,883; a decrease of \$38,729. <p>This Amendment is incorporated in and made a part of the contract. Except as amended herein, all other terms and conditions of the contract remain in full force and effect. Any reference in the original contract or an Amendment to the "contract" shall mean "contract as amended".
