## CERTIFICATIONS CONCERNING DESIGN AND CONTRUCTION OF LASER SPEED MEASURING DEVICES

I, Gerald W. Hannah, do state as follows:

I am employed by Technology Solutions Group under contract to Washington State Patrol as an Electronic SMD Engineer. I have been employed with Technology Solutions Group since April 18, 2006. Before that I served with Washington State Patrol in as its SMD Expert Witness for fifteen (15) years and held the position of Electronic SMD Engineer. Part of my duties includes supervising the maintenance, and repair of all electronic speed measuring devices (SMDs) used by Washington State Patrol.

The Washington State Patrol currently uses the following LIDAR (Laser) SMDs:

1. LTI 20-20
2. PRO-LASER II
3. LTI UltraLyte 100LR
4. PRO-LASER III

A List of the specific Laser SMD Instruments currently in use by this agency is attached here to as Exhibit "A". All of the LTI 20-20 and LTI UltraLyte 100LR SMDs are manufactured by *Laser Technology, Inc.*, 7070 South Tucson Way, Englewood Colorado, 80112, while all the PRO-LASER II & III SMDs are manufactured by *Kustom Signals, Inc.*, 1010 W Chestnut, Chanute, Kansas, 66720.

I have the following qualifications with respect to the above stated SMDs:

- ◆ I have over 40 years experience as a technician in the maintenance, repair, modification, and calibration of Radars (both Doppler and Pulse Search), Microwave Radios and Telemetry systems. I have fifteen years-specialized experience testing and certifying Laser SMDs.
- ◆ I hold and have held since 1968 a Federal Communications Commission License.
- ◆ I have received training from *Laser Technology, Inc.*, (the manufacturer of the LTI 20-20 LASER SMD) in the operation, theory, design, and construction of the LTI 20-20 and UltraLyte 100LR LASER Speed Detection Systems.
- ◆ I have received training from *Kustom Signals, Inc.*, (the manufacturer of PRO-LASER II & III SMDs) in the operation, theory, design, and construction of the PRO-LASER Speed Detection System.
- ◆ I have completed a two-year course in Electronics Engineering with Capitol Radio Engineering Institute.

This agency maintains manuals for all of the above state SMDs. I am personally familiar with those manuals and how each of the SMDs are designed and operated. On the dates indicated on exhibit "A" copy of which is attached to this declaration and incorporated herein by this reference, testing of the SMDs was performed under my direction. The units were evaluated and were found to measure the speed of vehicles accurately and are on NHTSA's/IACP's Minimum Performance Standards list. Our agency maintains a testing and certification program.

This program requires:

That at least once every two years each Laser SMD is tested and certified to be accurate within +1MPH – 2 MPH. The Laser SMD's accuracy is verified by comparing the measured speed of various vehicles with a Radar SMD that I have personally certified and tested for accuracy. The Radar SMDs used for this testing were either Decatur VPD R882 (s/n 00536), tuning forks 80196, 81093 or a Decatur VPD R2038 (s/n 035030), tuning forks 138499, 138343. The Radar units' calibration and date of testing can be found on the WSP "Certifications Concerning Design and Construction of Radar Speed Measuring Devices," which can be found on file with the court. A copy of this Laser Affidavit is available from the files of the District Headquarters if the court desires. All Laser SMDs used by the Washington State Patrol operate in the following manner described below.

When the trigger is pulled, all Laser SMDs operated by the Washington State Patrol send out a series of pulses of invisible light waves, which are very narrow in diameter (i.e., 3.5 ft in diameter at 1000 ft). As each pulse is transmitted, a timer started, and when the light pulse is reflected from a vehicle and received by the Laser gun the timer is stopped. From the time of flight taken for the light pulse to strike and return from the vehicle, the distance to the vehicle can be determined, since the speed of light is a known quantity. By taking additional range measurements using a series of these light pulses, the speed of a vehicle can be calculated

Based upon my education, training, and experience and my knowledge of the SMDs listed above, it is my opinion that each of these Laser SMDs are so designed and constructed as to accurately employ measurement techniques based on the velocity of light as constant in such a manner that each Laser SMD will give accurate measurements of the speed of motor vehicles when properly calibrated and operated by a trained operator.
