
### PUBLIC HEARING DISPOSITION OF COUNTY ASSETS AUDITOR

At 2:00 p.m. VICE-CHAIRMAN WACHSMITH opened a Public Hearing to consider the Disposition of County Assets through Selling on publicsurplus.com, to other Agencies, Trade Ins, and/or Disposal of Assets.

KAY KRESGE, FISCAL ANALYIST reviewed equipment that was recommended to be declared surplus to the County's needs. JUDY PLESS, BUDGET & FINANCE MANAGER said she was unsure of the Board's intent to surplus the Coke Stage, but if they decided to move forward they would need to do so by a separate Resolution. She said in 2017 there were improvements done in the amount of \$3,405.00 and paid out of Lodging Tax Funds to make it conform with the DOT regulations and would need to be repaid because it is its own dedicated fund. The stage had been gifted to the County by Coke. If the Board would like to move forward with transferring the stage to the City of Cle Elum they could prepare the necessary paperwork for consideration in the near future.

**COMMISSIONER OSIADACZ** said the Board previously decided to surplus the Coke Stage to the City of Cle Elum. She said it had not been utilized recently and that the previous Interim Event Center Director did their due diligence with the Fair Board to see if there was a need to keep it. The County did not want to be at risk for additional costs and any potential personal injuries.

THOSE PRESENT & TESTIFYING: ROYLENE CRAWFORD, FAIR BOARD MEMBER wanted to make sure the money to repay the Lodging Tax Funds would not be coming out of the Fair Budget. She said Director Jerry Jarnigan said he had not been approached whether it had been utilized or not and urged them to make sure they check with everyone before to giving it to the City of Cle Elum because once it's gone they will no longer be able to get it back.
