Bloom Pavilion Project Update: Patti informed the Board that the building passed inspection with the City Fire Marshal and that the final building inspection is scheduled for tomorrow.

Patti informed the Board that she is working with Kady Porterfield on grant funding for the next phase of the Bloom Project.

Maintenance Updates: None

OTHER BUSINESS: Bond in the amount of \$163,326.19 to be spent on the Jail. Patti asked the Board if they had any jail specific projects in mind for these funds. Discussion was held on the possibility of siding. Patti will look into square footage prices and check with Tim and Ben for input on the project.
