## Director's Report

Tristen Lamb gave updates regarding the following:

- Tine Rowan to retire at the end of August
- Fiscal Analyst position posted already due to historical difficulty filling that position
- Tristen Lamb is no longer functioning as Deputy IC, that role is currently filled by Chelsey Loeffers, and will be rotated among the other members of KCPHD Management team.
- Local funding allocations for funding for Local Health Jurisdictions are currently being finalized, primarily for COVID-19 vaccine outreach and promotion.

There was discussion regarding the IMT command structure changes, and the rotations of the Deputy IC position.

## Health Officer Update

Dr. Mark Larson updated the board on the following topics:

- Current Incident rate for COVID-19 Infection
- Vaccination rates in Kittitas County
- All counties in Washington going to Phase 3 on March 22
- COVID-19 and schools
- COVID-19 variant rates in Washington State
- COVID-19 infection surges and waves

There were questions from the board regarding general population resistance to receiving the vaccine in lower risk groups, vaccine supply and location sites, COVID-19 local vs. regional metrics, bus and camp capacity for 5<sup>th</sup> grade camp, what COVID-19 infection looks like after getting the vaccine, and when Kittitas County will receive Johnson and Johnson vaccine.

Tristen Lamb gave an update regarding the following house bills:

- HB 1152 Substitute bill has been brough forward an approved, HB 5641. WSALPHO worked closely with the bill sponsor on a striker that is an LHJ preferred alternative to what was originally proposed.
- SSB 5149 Foundational Public Health Services funding, beginning in fiscal year 2023.
- ESSHB 1258 Pilot program to allow for micro enterprise home kitchen operations.
