MISCELLANEOUS

Jeff Greer, Rotary Member, gave a presentation on a proposed Fieldhouse project at the West Ellensburg property to allow for additional recreational activities in the wintertime. He said the building would be two-stories and approximately 300x700 feet and include courts, an area with turf, a walking track, etc. Scott Rollins, Rotary Member, said they were hoping the County would join in on a partnership with the City of Ellensburg. They felt it would be a huge benefit for community members; have a great tourism component; and be accessible to groups for tournaments. Commissioner Wachsmith agreed to be the point person for the Board in discussions with representatives of the City of Ellensburg.
