## PUBLIC HEARING COMPOST PROCUREMENT POLICY SOLID WASTE

At 2:06 p.m. **CHAIRMAN OSIADACZ** opened a Public Hearing to consider an Ordinance Establishing a Compost Procurement Policy.

LISA LAWRENCE, ASSISTANT DIRECTOR reviewed a Staff Report and said that under the new 2022 Organics Management Law ESHB1799, Kittitas County is required to adopt a Compost Procurement Ordinance based on its population. This new ordinance will require that the county source compost for projects when possible.

THERE BEING NO ONE REQUESTING TO TESTIFY, THE PUBLIC PORTION OF THE HEARING WAS CLOSED.

ORDINANCE 2022-014 COMPOST PROCUREMENT POLICY SOLID WASTE

VICE-CHAIRMAN WRIGHT moved to approve Ordinance No. 2022-014, establishing a compost procurement policy for Kittitas County. COMMISSIONER WACHSMITH seconded. Motion carried 3-0.

## PUBLIC HEARING TARP-IT AIRPORT LEASE AIRPORT

At 2:09 p.m. **CHAIRMAN OSIADACZ** opened a Public Hearing to consider the Tarp-It Lease at Bowers Field Airport.

**DAVID OHL, AIRPORT DIRECTOR** reviewed a Staff Report and said that Lot H-12 has been occupied by Tarp-It, Inc. since January of 2019. This lease will bring Tarp-It into compliance with the Bowers Field leasing policy.

## PUBLIC HEARING ADA TRANSITION PLAN PUBLIC WORKS

At 2:15 p.m. **CHAIRMAN OSIADACZ** opened a Public Hearing to consider the adoption of the 2022 Americans with Disabilities Act (ADA) Transition Plan.

JOSH FREDRICKSON, ENGINEER reviewed a Staff Report and said the county is required to prepare an ADA Transition Plan to address deficiencies. An inventory of faculties in the right-of-way was conducted in 2014. Through that inventory sidewalks on Airport Road and Bowers Road were noted as needing maintenance and/or repairs. Two open houses were held, and applicable comments have been addressed and the ADA plan has been updated accordingly.

#### PUBLIC HEARING REGULATING PUBLIC CAMPING COMMISSIONERS

At 2:19 p.m. CHAIRMAN OSIADACZ opened a Public Hearing continued from November 1, 2022, to consider Amending Kittitas County Code Title 9 to Create a New Chapter entitles "9.55 Regulating Public Camping".

**EMLIY SMITH, ADMINISTRATIVE ASSISTANT** reviewed a Staff Report and said the Homelessness and Affordable Housing Committee recommends creating a new chapter of county code to regulate public camping, noting it would not go into effect until a sleep center is established. This ordinance compliments a similar ordinance the City of Ellensburg has passed.

ORDINANCE 2022-015 REGULATING PUBLIC CAMPING COMMISSIONERS

VICE-CHAIRMAN WRIGHT moved to approve Ordinance No. 2022-015, An Ordinance Relating to Camping and Creating a New Chapter to the Kittitas County Code Entitled "9.55 Regulating Public Camping." COMMISSIONER WACHSMITH seconded. Motion carried 3-0.

PUBLIC HEARING SUNCADIA PHASE 1 DIVISION 14 CDS

At 2:22 p.m. **CHAIRMAN OSIADACZ** opened a Public Hearing to consider the Suncadia Phase 1 Division 14 Preliminary Plat (LP-22-00004).

**KELLY BACON, PLANNER** reviewed a Staff Report and said that the applicant has submitted for 39 detached residential lots with associated roadway, open space, and service tracts on approximately

43.94 acres of land that is zoned Mater Planned Resort. Lots range from 6,800 to 22,100 square feet.
