## State Environmental Policy Act Determination of Non-Significance

Kittitas County through its annual Comprehensive Plan Docket process, **Description:** proposes County Code and Comprehensive Plan amendments to: amend KCC 17.08 and 17.15 to adopt regulations specific to accessory dwelling units; amend KCC Title 17 to remove the 2.5 story reference to building heights; change the land use and zoning designation of parcel 10970 to allow inclusion in the UGA and eliminate an island; Amend comp plan and land use table to reflect annexations and rezones from the previous year; amend KCC 17 to allow for the rebuild of non-conforming use and one time 10% expansion of building area; update KCC 17.15 rural LAMIRD land use table to allow art galleries as a permitted use in the general commercial zone; Update Title 17.92 to allow a maximum 2 year extension on temporary permits; amend KCC 12 to update and replace current road standards; amend KCC 16.10 defining building area and allowing non-conforming lots to be adjusted and remain non-conforming; amend title 14 to maintain compliance with the Community Rating System and National Flood Insurance Program; amend KCC 17.36.025 to add an example of the text intent for PUD density calculations; amend KCC 17.13 Transfer of Development Rights providing definitions and clarifying receiving sites, incentivizing the TDR program to preserve agriculture and environmentally sensitive areas; amend KCC 17.08 and 17.15 to add definition of contractor yards and develop criteria for allowed uses; amend Title 14.04.010 adoption of referenced standards to address fire flow.
