Jeremiah,

To summarize from the meeting held at Public Works yesterday, the permitted hydrant system incudes phases 4 & 5 already. Required fire flow appears to be covered between the hydrants and residential sprinklers. Roads and access is covered by Public Works as their standards are aligned with the fire codes. There is already an existing permit for the water tank (BP-21-00981) and the hydrant system (FM-21-00032). I mentioned during the meeting that a Knox box would be required for the gate and for the customer to check with the Fire Marshal's office for details. The hydrant system will have to be tested prior to sign off from the Fire Marshal's office to verify that the 100 GPM for 30 minutes is attained (a 5% reduction is allowed per preliminary plat approval due to the sprinkler systems required for the structures).
