NOTICE IS HEREBY given that Kittitas County CDS and the Kittitas County Hearings Examiner will meet at 2:00 p.m. on January 24, 2024 to conduct a virtual public hearing to consider the Tumbling Ridge Long Plat application (LP-23-00002). The proposal includes creating 7 residential lots ranging in size from 5.01-acres to 5.17-acres on parcel #952139 and #952140. The subject parcels are zoned Rural 5 The property is located approximately .4 miles northwest of the intersection of Bullfrog Road and I-90 off Jenkins Drive.

NOTICE IS HEREBY given that pursuant to WAC 197-11-355, Kittitas County Community Development Services did on, January 4, 2024, issue a Mitigated Determination of Non-Significance (MDNS) for the Tumbling Ridge Long Plat application (LP-23-00002).

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after review of a SEPA environmental checklist, other information on file with the lead agency and after considering existing laws and regulations that will be implemented by the applicant as part of the permit process. This information is available to the public on request.

This MDNS is issued after using the optional process in WAC 197-11-355. There is no further comment period on the MDNS. Any action to set aside, enjoin, review, or otherwise challenge this administrative SEPA action on the grounds of noncompliance with the provisions of Chapter 43.21C RCW shall be commenced on or before

**January 18, 2024 by 5:00 PM.**
