**Project Name (File Number):** WSDOT Bullfrog Maintenance Facility (PF-24-00001)

**Applicant:** Washington State Department of Transportation

**Location:** One unnumbered tax parcel, located at 151 South Bullfrog Rd. Approximately 340 feet South of Interstate 90. Located in a portion of the NE ¼ of the SE ¼ of Section 31, Township 20 N., Range 15 E., W.M. Unassigned map parcel.

**Proposal:** Washington State Department of Transportation has proposed the replacement of an existing fuel system located at the WSDOT Bullfrog Maintenance Facility. This project will remove the existing fuel system and replace it with a new fuel system.

Under Title 17.62.030, Public Facility Projects are processed in an abbreviated administrative format, which does not involve a public hearing. All comments will be considered in the decision-making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. Appeals to an administrative land use decision may be filed within 10 working days with Kittitas County Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1670.

**Environmental Review (SEPA):** Department of Transportation operated as lead agency for SEPA review of this project. A Determination of Nonsignificance (DNS) was issued by the lead agency on November 1, 2016.
