**WSDOT Bullfrog Maintenance Facility
Public Facilities Permit
PF-24-00001**

NOTICE IS HERBY given, Kittitas County Community Development Services did on February 23, 2024, approve a Public Facilities permit (PF-24-00001) for the removal and replacement of an existing fuel system with a new fuel system. The subject parcel (unnumbered) is located at 151 South Bullfrog Road, Approximately 340 feet South of Interstate 90. Located in a portion of the NE ¼ of the SE ¼ of Section 31, Township 20 N., Range 15 E., W.M.; unassigned map parcel number. The Washington State Department of Transportation submitted a Public Facilities permit application to Kittitas County Community Development Services on January 16, 2024, for the proposed project.
