Thanks for sending over. It looks mostly good. I do have a couple of questions/clarification.

- 1. It looks like the stream enhancement area has lowered from the original 11,943 sq ft to now 9,560 sq ft. I'm guessing this is due to the clearing buffer around the homes you put in. On the creekside is there any way to shrink that a bit or is it already at the minimums for fire code?
- 2. On the logs, I was thinking more like 5-6. It looks like you have at least 5 at 18" diameter. Would you be willing to up the trees to 6 in the creek? Especially there appears to be a 20" and 36" fir to be removed in Lot 9 that would be great for the stream. This could help to offset the less sq ft in the enhancement area.
- 3. Just to tie things together, can you add a note that the trees will be placed under an HPA permit with WDFW?
