Public health has reviewed this application. The intention is for the project to connect to the City of Ellensburg sewer and water within the next two years. However, in the interim, the current well must be tested for bacteria and nitrates. The septic tank must be pumped and inspected (with pumping records submitted to the health department), to be sure that it is currently functional, until city utilities are brought onto the site. If the septic tank has recently been pumped, please provide that documentation to the health department.
