Thank you for meeting with me on site this morning. WDFW agrees there is no typed stream on the property. There is a slight indication of a stream directly south of Pasco Rd. However, the past photos show that it goes dry seasonally and there is no above ground connection to downstream areas. By definition there cannot be an isolated Ns stream, so thus the segment has no typing and is an untyped swale. The residents should still avoid digging or moving the swale.

Good morning Scott,

This is Eron Drew. I was the biologist who visited the site. The photos were taken on 6/2/22. I did not prepare the site plan that was submitted on 11/16/22 but after reviewing it, the channel is in the appropriate location, although the driveway does not extend to the east side of the drainage as it is drawn in on that map. In actuality, the driveway area ends a couple of feet to the west of the drainage.

You won't have to do much work to investigate the channel. To the north of Pasco road it essentially becomes the ditch along the road for collecting stormwater. The ditch only extends laterally a few feet in either direction before petering out. There is no channel on that side of the road extending up the hill. Where it is mapped on the DNR map up the hillslope ,there is now a residential driveway.

I walked on that side of the road and could not find anything that appeared to be a channel beyond the roadside ditch. On the day I was at the site, there was standing water in the depression next to the road where the culvert emerges on its south side and a little bit of standing water adjacent to the culvert on the north side of the road, but no water was running in the channel or even through the culvert. The site visit occurred during the tail end of an unusually wet month of rainy weather so I expect that stormwater from the road was the source of the water.

I also investigated the area to the south of the road as a potential small wetland. However, it did not pass the wetland criteria.

There really isn't a very well defined channel at all where the drainage meets the wetland underneath a fir tree. It seems the water probably just disperses on the surface once it reaches the wetland.
