Notice is hereby given that on May 23, 2023, conditional preliminary approval was granted to Department of Natural Resources (State of Washington, landowners) for an administrative conditional use application to place a radio communication tower which is to be situated between existing communications towers on a 640-acre parcel. The subject property is zoned Forest and Range.
