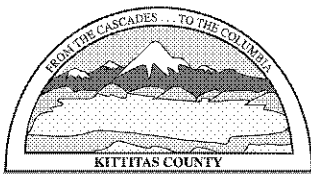
On April 24, 2009, Joe Spezialy, Landowner submitted an Accessory Dwelling Unit land use application which was deemed complete on May 11, 2009 by Kittitas County Community Development Services staff. The application is to construct an Accessory Dwelling Unit on approximately 20 acres of land that is zoned Agriculture 20. The subject property is located southwest of the City of Ellensburg, east of Bare Road, and north of Pumping Plant Road, Ellensburg, WA 98926; in a portion of Section 28, T17N, R20E, WM in Kittitas County. Assessor's map number 17-20-28000-0016. See attached vicinity map. The following permits are included or associated with this Accessory Dwelling Unit application: Building Permit 2006-7679 and Access Permit 2005-769.

The complete submitted application and related filed documents may be examined by the public at the Community Development Services office at 411 N Ruby Street, Suite 2, Ellensburg, WA 98926, as well as on the Community Development Services website at www.co.kittitas.wa.us/cds/current/. If you do not have internet access, or are unable to view the complete application at Community Development Services in person, one will be mailed on request.

Under Title 15A.03.080, Accessory Dwelling Unit Projects are processed in an abbreviated administrative format, which does not involve a public hearing. All comments will be considered in the decision making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. Appeals to an administrative land use decision may be filed within 10 working days with the board of county commissioners as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$500⁰⁰.
