Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Develop-ment Services granted approval for the Lumsden Administrative Use Permit (AU-11-00004) on October 12, 2011. The applicants, Scott and Sharon Lumsden, property owners, are proposing to construct an accessory dwelling unit in the Forest and Range zone per Kittitas County Code 17.56.100.
