Notice is hereby given that on October 16, 2013 conditional preliminary approval was granted to Jeff Hansell authorized agent for East AHM Development LLC, landowner, for a Binding Site Plan Amendment application to reconfigure one structure and the underlying property lines of a previously approved condominium complex. The subject property is zoned Master Planned Resort. The subject properties are multiple tax parcels (condominiums), located approximately 3.5 miles west of the City of Cle Elum, in Suncadia at the end of Suncadia Trail Road in a portion of section 19, Township 20N Range 15E Assessors map number for location reference 20-15-19058-0001.
