



Notice is hereby given that on May 14, 2015, conditional preliminary approval was granted to Chris Cruse authorized agent for Kittitas County Airport, landowners, for a binding site plan amendment application to reconfigure approximately 12 acres inside the Kittitas County Airport binding site plan. The subject property is zoned Light Industrial. The subject properties are located directly north of the City of Ellensburg at 713 Bowers Road, in a portion of Section 24, T18N, R18E, WM in Kittitas County, bearing Assessor's map numbers 18 18 24050 0001 and 18 18 23000 0001.
