Dear Mr. Watson:

Pursuant to your recent email, please accept this letter as a request to withdraw the referenced applications and process a refund. After discussions between our engineer and Dan Valoff, it was determined that an administrative segregation and boundary line adjustment would be sufficient to create the SnoPark parcel for the Evergreen Park Plat. We had applied for these applications to create the parcel in conformance with the conditions of the preliminary plat approval and the associated conditional use permit. Subsequently you were advised by the County's legal counsel to deny the applications.

In our meeting on February 23rd, CDS staff agreed that by granting a recreation easement to the Kittitas County Parks and Recreation District we would thereby meet the preliminary plat and conditional use permit conditions of the dedication of the SnoPark parcel prior to final approval.

As you stated in your email, Kirk Holmes has given the approval to withdraw the referenced applications and refund the fees for both of them.

Hi Dan,

Per my voice mail, here is what I was thinking for Evergreen Park since the Parks and Rec District is very close to losing their funding for this project. You may need to do a parcel history for this project and we will pay for your time to do that.

In order to create the sno-park area of ~5 acres, I was thinking we could do a tax lot segregation, since it has been 5 years or more since the last one, and split the current 45 acre parcel into 2 and boundary line adjust one of the parcels down to the ~5 acre parcel. The only change to the original plat is that there will be 2 tax parcels instead of one.....not a big deal. If anything, this will help meet the original conditions of the plat and a reason to take this route.
