It is my understanding that Lindsey will be handling short plats and up in the way of land use applications... I think I am only BLAs and Parcel Combinations. That being said, I have not heard anything additional from Craig or O'keefe from health; I think that Joe dropped off the Trent Mylars to Lindsey yesterday...?

On the BLA/Combo front I was told to focus all of my attention on the Compliance Effort/Public Record... that went on line yesterday. I have begun plugging in BLAs (working on BL-12-00033 now)... should move fairly quickly. If any of yours need special attention let me know and I'll light a fire under it (the State Parks/Palmer is in that bracket already). Monitor the on-line files to see how things are progressing or just give me a ring.

In the way of expirations... I can give you what I know on short plats... at least the ones that used to be mine up until Dan took them over... Rule of thumb is 7 years from Conditional Approval (180 days from a request for additional information if no CPA)... Segregations are all dead unless an extension was applied for prior to 12/18/2012. BLAs never die. Plats, Rezones, CUPs... No clue from my desk, we'll have to chase them down individually.

Sorry about all of the delays and confusion, it's been a bit wacky here since Dan quit, but I think things are stabilizing now...
