Dusty - My crew made it out to the Rossman property and had to adjust the proposed boundary as per the attached exhibit. The owner exposed the drain field to verify the location but I did not realize the piping from the tank to the drain field was north of the drain field. The attached layout matches the areas exactly as per the original application but we simply jogged the boundary to meet the 15' side yard setback from all infrastructure.
