The new boundary lines are not clear compared to the existing lines in the site plan. Is the well within the pump house or alongside? Where? Distance from well to proposed boundary line isn't clear.

Please request that actual measurements are provided.
Sorry to sound like a broken record but it's common to provide the least amount of information and have to continue to request, review and re request.
Its best to review every site plan against the unified site plan as is referenced on their application prior to accepting the application. The text below is copied from your BL application.

Unified Site Plan of existing lot lines and proposed lot lines with distances of all existing structures,
access points, well heads and septic drainfields to scale.
___ Signatures of all property owners.
___ Narrative project description (include as attachment): Please include at minimum the following information in your description: describe project size, location, water supply, sewage disposal and all qualitative features of the proposal; include every element of the proposal in the description.

If it doesn't have all of the measurements marked and meet the USP requirements, don't accept the application as complete.
