- 4. The statement for Survey Instrumentation appears to have been cut off.

5. The section line dimension near Tract B is partially obscured by crossing linework.

6. This page shows a Basis of Bearing. Clarify how this relates to the Basis of Bearing on Sheet 1 or remove.

Sheet 12

7. The line labeled as being 383.10 and the arc 290.36 in length along the north line of Tumble Creek drive do not match the closure report.

8. The applicant is advised that in future, Kittitas County would accept new legal descriptions that read as such;
