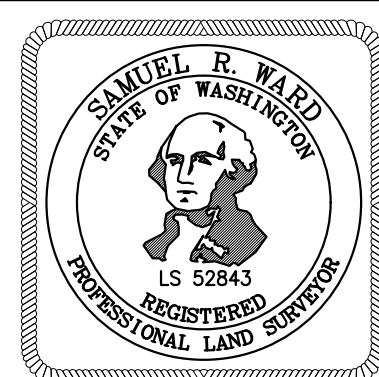
INDEX LOCATION

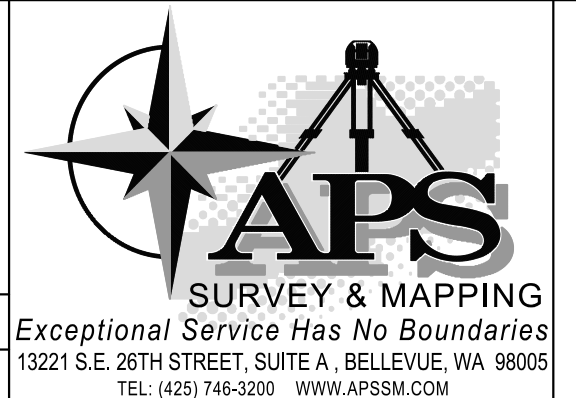
