Portions of the Niehoff BLA lie within the Kittitas Reclamation District (KRD) however it does not contain irrigable ground. KRD requests the following plat notes:

- 1. "KRD Operations and Maintenance roads are for District use only. Residential and recreational use is prohibited."
- 2. "KRD is only responsible for delivery of water to the highest feasible point in each 160acre unit or designated turnout. The KRD is not responsible for water delivery loss (seepage, evaporation, etc) below the designated turnout."

KRD would also like to note, due to the narrative filed regarding the BLA. It is the landowner's responsibility to work with adjacent landowners to receive water through a private delivery system from the KRD turnout. KRD water can only be applied to lands assessed as irrigable by the US Bureau of Reclamation. Please contact KRD to verify those allowable acres.
