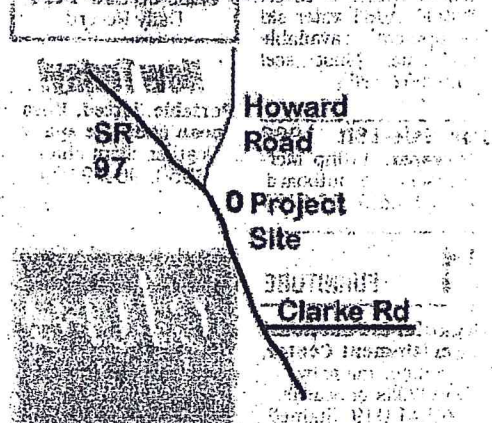


**Notice of Application  
Intosh 1, 2 & 3 CUP**

Pursuant to RCW 36.70B and KCC 15A, notice is hereby given that Kittitas County did on June 12, 2006 receive 3 (three) Conditional Use Permit Applications from Scott and Gayle McIntosh land owners for rock and gravel excavation for ponds in the Agriculture-20 zone (KCC 17.28.130(6)). Location: northwest of the City of Ellensburg and east of SR 97, Ellensburg, WA 98926 which is a portion of Section 08 T 18N R 18E SW M in Kittitas County located on a portion of parcel number(s) 18-18-08020-0001 & 18-18-08020-0002 & 18-18-08020-0003.

The submitted application and related filed documents may be examined by the public at the CDS office between 8:00 AM and 5:00 PM at 411 N. Ruby St. #2, Ellensburg, WA 98926. Phone (509) 962-7536. Written comments from the public may be submitted to CDS no later than June 30, 2006 @ 5:00 p.m., after which a SEPA threshold determination will be issued pursuant to 4321C RCW (State Environmental Policy Act) and WAC 197-11-655 (Optional DNS Process). This may be the only opportunity to comment on the environmental impacts of this proposal pursuant to SEPA, as a Determination of Non-Significance (DNS) is expected to be issued. A copy of this subsequent threshold determination will be available to the public upon request. This proposal may include, incorporate or require mitigation measures under applicable codes regardless of whether a Determination of Significance (DS) is issued and subsequent Environmental Impact Statement (EIS) is prepared.

An open record hearing is tentatively scheduled to go forward before the Kittitas County Board of Adjustment on Wednesday, August 14th, 2006 @ 7:00 PM, Commissioners Auditorium Kittitas County Courthouse. Interested persons are encouraged to verify by contacting CDS prior to attending.
