

It has been brought to my attention that activity taking place on the McIntosh property located on parcels # 18-08020-0001, 0002 & 0003 in relation to CUP's # 06-11, 06-12 & 06-13 is non-compliant with the conditions of the mitigation

determination of non-significance (MDNS) and the findings of fact and conclusion law signed and approved by Stan Bossart, Chairman, Board of Adjustment on June 13, 2008.

The areas of specific concern and violation include, but are not limited to the following:

I(D) Transportation: Prior to performing any work, the applicant shall obtain all required permits, including but not limited to; Washington Department of Transportation.

III(C) Project: The applicant shall consult with the Washington Department of Fish and Wildlife on the implementation and restoration plan for the <u>site prior to excavation</u> and submit the approved plan to Community Development Services.

In addition to the above and in relation to the required site visit we also need to review and discuss the Sand and Gravel permits, NPDES construction permit, storm water pollution prevention plans, DFW restoration plans, WSDOT construction and access review and any and all permits in relation to floodplain development regulations set forth by FEMA.

Without the above listed items, required site visit and review by both CDS and Public Works this project must be halted and as such I am issuing this email as a notice to immediately "stop work" so that we may address these issues.
