TO THE RESPONDENTS:

upon you with this Summons.

In order to defend against this lawsuit, you must respond to the Petition by stating
your defense in writing, and serve a copy upon the undersigned attorney for the Petitioners

1 within twenty (20) days after the service of this Summons, excluding the day of service, or
2 within sixty (60) days if service is made upon you outside of the State of Washington, or a
3 default judgment may be entered against you without notice. A default judgment is one
4 where the Plaintiff is entitled to what it asks for because you have not responded. If you
5 serve a Notice of Appearance on the undersigned attorney, you are entitled to notice before a
6 default judgment may be entered.


7 You may demand that the Petitioners file this lawsuit with the Court. If you do so,
8 the demand must be in writing and must be served upon the Petitioners. Within fourteen
9 (14) days after you serve the demand, the Petitioners must file this lawsuit with the Court, or
10 the service on you of this Summons and Petition will be void.

11 If you wish to seek the advice of an attorney in this matter, you should do so
12 promptly so that your written response, if any, may be served on time.

13 This Summons is issued pursuant to Rule 4 of the Superior Court Rules of the State
14 of Washington.
