

Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that on August 6, 2013 the Kittitas County Board of County Commissioners approved the Canyon River Ranch Conditional Use Permit (CU-12-00002). The project is located approximately at Milepost 15 on Canyon Road (Highway 821) lying easterly of the Yakima River in the SW ¼ of Section 28, T16N, R19E, W.M. in Kittitas County, Washington.
