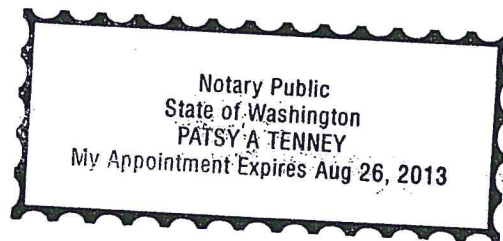

NOTICE IS HERBY given that pursuant to 43.21C RCW, Kittitas County Community Development Services did on April 29, 2013 receive a timely appeal of a Mitigated Determination of Non-Significance (MDNS) for the Steigleder Conditional Use Permit. The proposal is for a conditional use permit to operate a produce stand on approximately 2.95 acres. Located approximately one (1) mile southeast of Thorp at 8341 S. Thorp Hwy, in a portion of Section 13, T18N, R17E, W.M. in Kittitas County.
