The Applicant proposes to utilize portable toilets in lieu of public restrooms with flush toilets, and without soap and running hot water for personal hygiene. After using a portable toilet, customers will most certainly handle fruits on display, thus enabling diseases to be passed onto subsequent customers. Likewise, the lack of approved water will pose dangers to public health and safety. The lack of adequate fire protection and the site's close proximity to combustible Agricultural products such as hay, wheat, etc. pose a very real and significant fire risk to those commercial Agricultural products, and nearby dwellings, and buildings related thereto. Any approval of this Conditional Use should be predicated upon the prior installation of fire suppression system capable of providing the fire district a minimum of 1500 gallons of water, for two hours, and no more than 60 pounds head pressure, without the need of electrical power to deliver this water. This is consistent with the mitigation requirement mandated upon Thorp Fruit in order for it to commence operation of a business on their site.

The Applicant over the last several years has operated in three different locations. At all three locations, the Applicant has previously proliferated the immediate areas with unsightly road side signs. This practice will blight the area, and degrade the rural character of that part of the County.

The Applicant vastly understates the potential size and scope of their proposed operation; as well as, the impacts to County services, and dangers to public health and safety. The Applicant's proposed operation literally has no "association with agriculture" since virtually all agricultural products, sold by fruit stands located within Kittitas County, are grown outside Kittitas County, and this proposed operation will not provide any significant benefits to the local agricultural economy. Instead this operation should be classified for what it is, and that is as a commercial operation. Consequently, the Applicant's should be required to utilize one of the numerous commercial sites available elsewhere in the County, as have other similar businesses, such as: Red Sky Orchards, Thorp Fruit & Antique Mall, Big Apple County Store, Kittitas Fruit Stand, and Carlson's Fruit Market.
