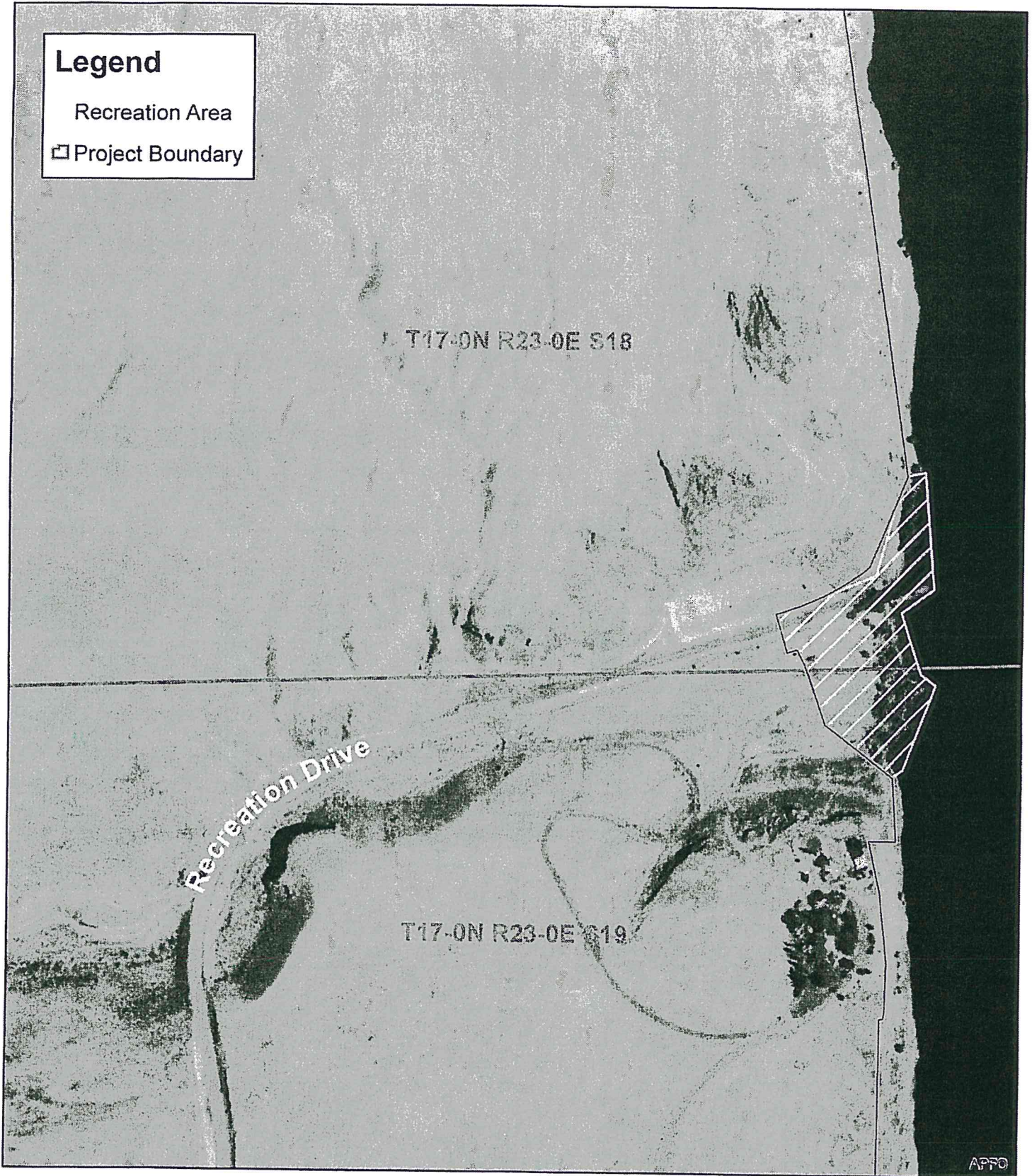

Recreation Area

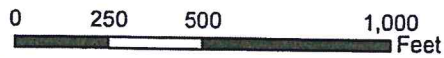
□ Project Boundary
