I will be sending GC PUD and WA Parks an email shortly with a transmittal letter that was sent to Dept. of Ecology today. The County approved the CUP and Shoreline Substantial Development Permit, but we also have to send it to Ecology for their approval because of the Shoreline. I could not send them the file for their review until after the appeal period ended.

In regards to when and what will be required for meeting condition of approval no. 13, I will refer you to our Public Works Department. Christina Wollman should be able to assist you with what will be necessary to meet this condition.
