1. AGENCY ISSUING ADDENDUM:

Public Utility District No. 2 of Grant County, Washington (Grant PUD) P.O. Box 878 Ephrata, WA 98823

2. DESCRIPTION OF AGENCY ACTION:

Grant PUD issued the original SEPA DNS and Environmental Checklist based upon preliminary design information for the Rocky Coulee Tent Camping Project on March 14, 2013. The DNS was published twice consecutively in the Columbia Basin Herald, Ellensburg Daily Herald and the Wenatchee World during the weeks of March 21 and 28, 2013. The following information presented in the checklist has been updated.

Internal review by Grant PUD misidentified the property ownership of the southernmost segment of the project site located in the northeast ¼ of Section 19, Township 17 North, Range 23 EWM, Kittitas County, Washington. This unnamed parcel has been determined to be owned by the Washington State Parks and Recreation Commission as part of the Gingko Wanapum State Park Development.

This addendum is intended to inform the recipients of the original SEPA Determination of Nonsignificance and the Environmental Checklist dated March 14, 2013 for the Rocky Coulee Tent Camping project of the above clarification to project area land ownerships. Grant PUD is working with the Washington State Parks and Recreation Commission to gain written approval for this

recreational development. This clarification does not change the Determination of Nonsignificance for this proposal.

The site is located in Sections 18 and 19, Township 17 North, Range 23 EWM, Kittitas County, Washington.
