From Ecology's point of view, the easiest way to deal with the wetland issue is to verify that the site wetland(s) are not within the boundaries of the proposed development or within required buffer areas. I did not find a wetland delineation report when I went to the County website. Do you have pictures of the site? I assume that the site has been somewhat altered already by grazing or growing crops of some sort, so I would be happy to make a site visit, dig into the dirt and determine whether the proposal area is located within a wetland. Even if a portion of the site contains a wetland area, the parcel is so large that some sort of wetland mitigation would probably be relatively easy to accomplish nearby. I am available tomorrow (Friday the 4th) in the afternoon, next week on Monday afternoon(7th), 10th, 14th, for a site visit and other times this month.

There was also a critical areas map and critical areas checklist included in the "Master File" which clearly indicated the existence of the wetland, the file also included a US Fish & Wildlife description of a PEMC Wetland. I was hoping to get this in front of the Hearings Examiner on the 24th of April… hopefully we can get this cleared up by then. Let me know what you think.
