Dear Holly,

The purpose of the call was to simply inform you of the measures taken to comply with the requests you had made at the previous meeting regarding my administrative conditional use permit application.

In regards to your sanitation requirements:

You had indicated that a portable toilet, hand wash station and availability of bottled water on site would be the appropriate option for our seasonal outdoor farming operations. We have brought these capabilities to the site which should be sufficient for the approximate 8 seasonal employees.

In regards to your water use requirements:

There was some confusion on my part at the previous meeting as to if my existing well was legal for use and your guidance was to talk to state ecology to clarify this along with questions of what is a legal means of acquiring water by truck delivery. I did discuss the matter with Sage Park and was informed that senior rights needed to be acquired to use the well. Sage also said using truck delivered water was fine if the provider was licensed for this purpose and acquired the water from a source with senior agricultural rights.

I am in the process of acquiring these specific senior rights for my well, but have already made arrangements to have legal water delivered by truck to address near term needs. This delivery service will begin next week and we currently have the on site capability for holding 4300 gallons. Initially, this amount of water should last more than a couple weeks and during the peak cycle of the plants they may need water delivery every 4-5 days, longer delivery intervals if additional storage is brought on site.

If you can indicate if these plans meet your approval, if you have additional requests, or if I have misunderstood your direction in any way.
