**Notice of SEPA Action  
NMF Enterprises Administrative Conditional Use Permit  
(CU-14-00002)**

Notice is hereby given that the lead agency for this proposal, Kittitas County Community Development Services, has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.030 (2)(c) and WAC 197-11. This decision was made after review of a completed environmental checklist and other information on file with the lead agency.

A Notice of Application and intent to utilize the optional DNS process was issued and published in the legal newspaper of record on June 6, 2014 establishing a 15 day comment period for all interested persons, parties, and agencies. The comment period was extended to July 8, 2014 due to technical errors. As per WAC 197-11-340 & 390 the lead agency is issuing the Mitigated Determination of Non-Significance (MDNS) for this proposal.
