TJ McDonald of Ellensburg has filed for an administrative conditional use permit to allow the first phase of the business at 1006 Emerson Road. The property is zoned for commercial agricultural activity.

I WOULD LIKE TO KNOW HOW TO APPLY IN THE CITY OF ELLENSBURG TO GROW MY OWN PERSONAL MARIJUANA MEDICINE WITH OUT A PERMIT AND OR FEAR OF POLICE VIOLATING ME JUST BECAUSE I DO NOT HAVE A PERMIT OR ISSUE CARD FOR PLANTING MY OWN MEDICAL MARIJUANA.

CAN YOU HELP ME HOW TO APPLY OR TO WHOM. I LIVE IN THE CITY LIMITS BY INDIANA DR ELLENBURG AND I WOULD LIKE TO PLANT ABOUT SIX PIECES OF MARIJUANA PLANT FOR MY PERSONAL USED WITH OUT A LICENSE OR PERMIT FOR MY PERSONAL USED AND FOR MEDICAL REASON AND I CANNOT AFFORD TO PAY FOR LICENSE FEE OR PERMIT.

I WOULD LIKE TO GROW SIX PLANT IN MY BACK YARD I WILL COVER IT. HOW CAN I DO THIS WITHOUT PERMIT OR LICENSE AND A FEAR OF THE POLICE.

I WILL TERMINATE THE PLANTING ONCE I GOT NOTICE FROM THE CITY OR THE POLICE BUT NO PROSECUTIONS ONCE I REMOVE IT IF SOMEONE COMPLAIN.

PLEASE HELP ME I DO NOT HAVE MONEY TO PAY FOR LICENSE FEE OR MEDICAL CARDS BUT I NEED AND WOULD LIKE TO PLANT SIX MARIJUANA PLANT THIS COMMING SPRING IN MY BACKYARD FORTCH.

WHERE CAN I APPLY OR TO WHOM AGENCY IN ELLENSBURG CITY LIMITS SO I CAN PLANT MARIJUANA PLANT IN MY HOUSE WITHOUT A LICENSE OR ID CARDS BECAUSE I DO NOT HAVE MONEY TO PAY FOR ALL THOSE REQUARMENTS AND I KEEP BUYING IT AND THE CITY LEGALIZE IT FOR AMERICAN.
