The seven calls in a six week period leave the rest of us without protection in time of need as there are only two to three officers on duty for the entire county at night. This same facility has already had one fire, so now we want two facilities depleting our limiting county resources so the rest of the county tax payers are left without service when needed?
- 2. Robert McKendrick has done work on a farm in proximity of approximately of ¾ mile from Life Gardens, producer in Badger Pocket and was appalled at the strong odor of the marijuana permeating the air.
- 3. Mr. McDonald also had a Marijuana Delivery business known as Rodeo City Meds. This will increase traffic in the area and on Thrall road drastically. These are farm roads never meant as high traffic areas, not to mention the families with children who play near these roads.
- 4. In reviewing the application of Mr. McDonald I am VERY concerned with the environmental elements. "Burning and composting sewage"? How can this be? I am sure when this is presented to the environmental protection agency they are not going to be happy with Kittitas County allowing such.
