The subject property is located to the Southeast of Ellensburg at 1006 Emerson Road in a portion of Section 27, T17N, R19E, WM, in Kittitas County, Assessor's map number 17-19-27053-0002.

The appeal deadline for this project is May 6, 2015 at 5:00p.m.
