DOH agrees with their approach.

Per "signage", DOH would be looking for a sign or signs (either a very "large" sign somewhere near the entry to the facility, or smaller, yet obvious, signs at each faucet/spigot/hydrant) that state: "DO NOT DRINK THE WATER – NONPOTABLE". Also, depending on owners, contractors and potential employee ethnicities and so forth, bilingual signs may be reasonable.

At this point, as long as they do not have an approved water system, providing these signs is the only involvement DOH has with this business.

In the future, if they do seek/need an approved water system, they need to be aware that pulling together source and water system approval applications, from start to approval, can take several months and parts require a Professional Engineer, licensed in the State of Washington.
