You are welcome. I do want to remind you that the shoreline conditional use permit and shoreline substantial development permit will need to be approved by Department of Ecology. A copy of the project file will be transmitted once the 21 day LUPA appeal is over. Once you successfully obtain approval from DOE and you provide documentation that the conditions of the project have been met to Kittitas County, the County will then issue the Final Zoning Conditional Use Permit for the site.
