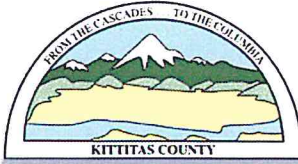

Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that on July 21, 2015 the Kittitas County Board of County Commissioners approved WDFW Hwy 10 Zoning Conditional Use Permit, Shoreline Substantial Development Permit, & Shoreline Conditional Use Permit (CU-14-00006 & SD-14-00003). The subject property is located at MP 101 on Hwy 10 along the eastern shore of the Yakima River, in a portion of Section 12, T. 18 N., R. 17 E., W.M. in Kittitas County, bearing Assessor’s map number 18-17-12020-0009.
